- All applicants must have a valid WV Business Registration Certificate before receiving a business license from the City of Point Pleasant
 - Register with Secretary of State Office

- Fill out and return the City of Point Pleasant Business License Application

Things to Remember

- Vendors may only setup within areas zoned as business districts
 - See attached zoning map
- No setup is permitted along Main St. between 4th St. and 6th St. due to limited business parking
 - You may utilize parking spaces in adjacent streets or lots
 - Organized events and festivals are an exception to this
- To set up in parking lots throughout town, please obtain written permission from the owner/manager of the entity
- No long term set-up
 - Must be packed up and moved by 9:00 pm each day
 - Unless otherwise permitted by event organizers
- As a courtesy, please do not setup in front of another restaurant
- To set up during organized events and festivals in Point Pleasant, please contact the event directors for any additional fees or regulations


